CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MRS. ANNA GRAHAM

of PO Box 2135, Heppner, State of Oregon 97836, has a right to the use of the waters of Willow Creek

a tributary of Columbia River for the purpose of irrigation of 22.0 acres (beginning in April of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for MORROW County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 73; that the priority of the right thereby confirmed dates from 1889 for 0.08 cfs and 5.0 acres and 1891 for 0.29 cfs and 17.0 acres

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.37 cubic feet per second, if available at the original point of diversion; NE 1/4 NW 1/4, Section 27, T2S, R26E, WM; Dutton and Clark Ditch-1,000 feet South and 1,600 feet East from NW Corner, Section 27.

The point of diversion is located in the NE 1/4 SW 1/4, Section 21; SE 1/4 SE 1/4, Section 17; T2S, R26E, WM; 1 - 240 feet South and 1,120 feet West from the Center of Secton 21; 3 - 600 feet North and 680 feet West; both from the SE Corner Section 17.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use and points of diversion approved by an order of the Water Resources Director entered September 12, 1977 and supersedes Certificate 127, Volume 1, State Record of Water Right Certificates

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
