## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HOWARD M. ROBERTSON

of Route 1, Forest Grove , State of Oregon 97116 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Washington County Drainage Ditch 7

a tributary of Dairy Creek irrigation of 19.4 acres

for the purpose of

under Permit No. 19209 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

October 27, 1949 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.243 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, Section 9, TlN, R4W, WM; 1150 feet South and 920 feet East from the NW Corner, SE 1/4 NW 1/4, Section 9.

The amount of water used for irrigation, together with the amount secured under any other  $right\ existing\ for\ the\ same\ lands,\ shall\ be\ limited\ to_{\mbox{ONe-eightieth}}$  of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SW 1/4 NE 1/4 1.9 acres SE 1/4 NW 1/4 12.1 acres NE 1/4 SW 1/4

4.6 acres NW 1/4 SE 1/4

Section 9

Township 1 North, Range 4 West, WM

This certificate is issued so as to correctly describe the location of the place of use and supersedes Certificate of Water Right recorded at page 20118, Volume 14. State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
