## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JAMES C. HATHAWAY

of Route 3, Box 407, Corvallis , State of Oregon 97330 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River

a tributary of Columbia River for the purpose of irrigation of 119.8 acres and supplemental irrigation of 25.0 acres

under Permit No. 43296 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Nuclet 9, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.94 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4, Section 24, T12S, R5W, WM; 1320 feet North and 280 feet West from SE Corner Section 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year provided further, that although declared herein to be for supplemental irrigation, the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

conform to such reasonable rotation system as may be ordered by the proper state officer.
