CERTIFICATE OF WATER RIGHT

This is to certify, That

LES SCHWAB TIRE CENTERS, INC dba L. S. RANCH

of P. O. Box 667, Prineville , State of Oregon 97754 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Maury Creek and Mainline Reservoir 1 constructed under Permit R-4871

a tributary of Crooked River irrigation of 68.5 acres

for the purpose of

under Permit No. 32025 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 26, 1966 for storage and November 2, 1966 for Maury Creek that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.71 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SW 1/4; NE 1/4 SW 1/4, Section 10, T175, R21E, WM; Reservoir - 4,460 feet South and 130 East, Pump - 2,670 feet South and 1,450 feet East, both from NW Corner Section 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-4871

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.2 acres NW 1/4 NE 1/4
19.9 acres SW 1/4 NE 1/4
25.4 acres NE 1/4 NW 1/4
21.0 acres SE 1/4 NW 1/4

Township 17 South, Range 21 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
