CERTIFICATE OF WATER RIGHT

This is to certify, That NORMAN L. BURDON

of 7975 Sawtell Road, Sheridan, State of Oregon 97378, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River for the purpose of irrigation of 20.9 acres and supplemental irrigation of 9.6 acres

under Permit No. 40598 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 21, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4 as projected within G. Lawson DLC 48, Section 14, T6S, R7W, WM; 1,970 feet North and 1,850 feet West from SE Corner, Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

PRIMARY

- 10.9 acres NE 1/4 SW 1/4 as projected within G. Lawson DLC 48
2.0 acres NE 1/4 SW 1/4 as projected within Tharp DLC 52
7.7 acres NW 1/4 SE 1/4 as projected within G. Lawson DLC 48
0.3 acre NW 1/4 SE 1/4 as projected within Doane DLC 55

SUPPLEMENTAL

- 5.0 acres NW 1/4 SE 1/4 as projected within G. Lawson DLC 48
3.1 acres NW 1/4 SE 1/4 as projected within Doane DLC 55
1.5 acres SW 1/4 SE 1/4 as projected within Doane DLC 55

Township 6 South, Range 7 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
