CERTIFICATE OF WATER RIGHT

This is to certify, That ADRIAN LULAY FOR SANTIAM WATER CONTROL DISTRICT

of 10981 Shaff Road, S.E., Aumsville, State of Oregon 97325, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Santiam River

a tributary of Santiam River for the purpose of irrigation of 54.2 acres

under Permit No. E-82 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1909 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.68 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SW 1/4 SE 1/4) Section 11, T9S, R1W, WM; 1,800 feet South and 2,830 feet East from West 1/4 Corner, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.6 acres Lot 2 (SW 1/4 NE 1/4)
15.5 acres SW 1/4 NE 1/4 as projected within Porter DLC 40
4.4 acres SE 1/4 NE 1/4 as projected within Porter DLC 40
0.5 acre Lot 1 (SE 1/4 NE 1/4)
7.5 acres NE 1/4 SE 1/4 as projected within Porter DLC 40
11.5 acres NW 1/4 SE 1/4 as projected within Porter DLC 40
2.8 acres SW 1/4 SE 1/4 as projected within Porter DLC 40
10.4 acres SE 1/4 SE 1/4 as projected within Porter DLC 40
Section 6
Township 9 South, Range 1 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
