CERTIFICATE OF WATER RIGHT

This Is to Certify, That ANDREW O. LUN

of North Powder, State of Oregon, has a right to the use of the waters of North Powder River

a tributary of Powder River for the purpose of irrigation of 231.9 acres, domestic, stock use, and ice-making from October 15 to March 1 of each year

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 252; that the priority of the right thereby confirmed dates from 1884 for the irrigation of 37 acres; from 1870 for 194.9 acres; from 1886 for the use of 2.50 second feet for ice making that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow for irrigation of 5.87 second feet from March 1 to July 1 and 2.90 second feet from July 1 to October 1 of each year; the total quantity diverted during each irrigation season not to exceed 579.5 acre-feet

The point of diversion is located in the NE 1/4 SE 1/4, Section 28, T6S, R39E, WM; Lun Ditch - 2,600 feet North and 440 feet West from SE Corner, Section 28
