CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatLES SCHWAB TIRE CENTERS, INC
dba L. S. RANCH

of P. O. Box 667, Prineville, State of Oregon 97754, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Crooked River, Stewart Creek, Sarvis Creek and 2 reservoirs constructed under Permits R-1422 and R-1423 a tributary of Crooked River for the purpose of irrigation of 63.9 acres and supplemental irrigation of 18.0 acres

under Permit No. 21721 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 5, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.81 cubic feet per second being 0.50 cfs from Sarvis Creek, 0.10 cfs from Stewart Creek and reservoirs, and 1.21 cfs from Crooked River, if available at the original point of diversion in the NE 1/4 NE 1/4, Section 9, T17S, R12E, WM or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4, SE 1/4 NW 1/4, NE 1/4 SW 1/4, Section 8; NW 1/4 NE 1/4, SE 1/4 NW 1/4, Section 9; NE 1/4 NE 1/4 Section 19; T17S, R21E, WM; Crooked River diversion point located 810 feet South and 2,370 feet West from the NE Corner Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permits R-1422 and R-1423

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
