and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 449; that the priority of the right thereby confirmed dates from 1891

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for domestic and stock use, and 3.34 cubic feet per second for irrigation from July 1st to September 15th of each year, the total quantity being limited to six acre-feet per acre during each year, if available at the Stearns Dam.

The point of diversion is located in the SW 1/4 SE 1/4, Section 1, T16S, R15E, WM; Stearns Dam - 100 feet North and 1500 feet West from SE Corner, Section 1 SW 1/4 SE 1/4; SE 1/4 NE 1/4, Section 36, T15S, R16E, WM; 5260 feet South and 1960 feet West, 1550 feet South and 40 feet West, both from NE Corner, * A description of the place of use under the right, and to which such right is appurtenant, is as follows:
