CERTIFICATE OF WATER RIGHT

This is to certify, That ROBERT JAMES McCREARY AND MARION E. MARTIN

of North Myrtle Route, Box 276, Myrtle Creek, State of Oregon 97457, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Myrtle Creek

a tributary of South Umpqua River for the purpose of irrigation of 6.0 acres

under Permit No. 3458 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1917

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.08 cubic foot per second, if available at the original point of diversion, SW 1/4 SW 1/4, Section 27, T28S, R4W, WM; 1192 feet North and 1234 feet East from NE Corner, Section 33.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, Section 33, T28S, R4W, WM, McCreary - 1210 feet South and 630 feet West; Martin - 980 feet South and 670 feet West, both from NE Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighthieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

McCreary 4.7 acres NE 1/4 NE 1/4 Section 33 Township 28 South, Range 4 West, WM Martin 1.3 acres NE 1/4 NE 1/4

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered April 26, 1979, and together with certificate of water right recorded at page 48131 Volume 41, State Record of Water Right Certificates, supersedes certificate 3230.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
