and that said right to the use of said waters has been perfected in under Permit No. G-1199 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

November 24, 1958 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.044 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 SE 1/4, as projected within T. Whitted DLC 44, Section 32, T29S, R5W, WM; North 88 degrees 17 minutes 20 seconds West 2355.6 feet from the SW Corner, Adams DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second existing for the same lands, shall be limited to per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 30074, Volume 22, State Record of Water Right Certificates changed from primary to supplemental irrigation by the provisions of an order of the Water Resources Director entered on May 7, 1984 and together with Certificate 52548 supersedes Certificate 30074.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
