that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three per acre during irrigation season (with the further limitations contained in paragraph 24 of said decree); if available at the original point of diversion; NE 1/4 SW 1/4, Section 3, T4S, R13E, WM; 910 feet South and 1010 feet West from Center of Section 3 (Bonney Ditch).

feet South and 1940 feet East from the NW Corner, NE 1/4 NW 1/4, Section 11.
