under Permit No. 19242 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

January 10, 1950

is appurtenant, is as follows:

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.446 cubic foot per second; being 0.394 cfs from West Fork Dairy Creek, 0.039 cfs from unnamed creek, and 0.003 cfs from spring for irrigation; and 0.01 cfs from unnamed creek for domestic use and stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\,$ N 1/2 NE 1/4 from West Fork Dairy Creek; SW 1/4 NE 1/4 from unnamed creek; SE 1/4 NE 1/4 from spring, all being within Section 9, T2N, R4W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
