of Pine Valley Ranch, Halfway , State of Oregon 97834 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Pine Creek

a tributary of Snake River supplemental irrigation of 360.3 acres

for the purpose of

under Permit No. 42940 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 9, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.0 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 24, T8S, R46E, WM; 1660 feet South and 730 feet East from NW Corner Section 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
