CERTIFICATE OF WATER RIGHT

This is to certify, That EARL FRANKLIN

of Route 3, Box 581, Corvallis, State of Oregon 97330, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Long Tom River for the purpose of supplemental irrigation of 112.3 acres

under Permit No. G-6515 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

June 25, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.4 cubic feet per second; being 0.35 cfs from Well 1, 0.70 cfs from Well 3 and 0.35 cfs from Well 4

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NE 1/4, SW 1/4 NE 1/4, as projected within Criss DLC 69, Section 3, T14S, R5W, WM; Well 1 - 2160 feet North and 1160 feet West; Well 3 - 1420 feet North and 1180 feet West; Well 4 - 800 feet North and 1210 feet West; from the SE Corner DLC 69.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.6 acres SE 1/4 SW 1/4 as projected within Criss DLC 63
 14.7 acres SW 1/4 SE 1/4 as projected within Criss DLC 63
 6.4 acres SE 1/4 SE 1/4 as projected within Criss DLC 63
 Section 34
 Township 13 South, Range 5 West, WM

33.3 acres NW 1/4 NE 1/4 as projected within Criss DLC 69
 8.8 acres SW 1/4 NE 1/4 as projected within Criss DLC 69
 26.0 acres NE 1/4 NW 1/4 as projected within Criss DLC 69
 15.5 acres SE 1/4 NW 1/4 as projected within Criss DLC 69
 Section 3
 Township 14 South, Range 5 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
