CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DORIS CRISP and BRIAN SULLIVAN et al

of PO Box 817, Heppner , State of Oregon 97836 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Columbia River

a tributary of $\mbox{Pacific Ocean}$ for the purpose of irrigation of 42.3 acres and supplemental irrigation of 85.2 acres

under Permit No. 35005 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 12, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.0 cubic feet per second, being 1.76 cfs for Crisp and 0.24 cfs for Sullivan

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4, Section 1, T3N, R22E, WM; 3690 feet North and 2610 feet West from SE Corner, Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
