## CERTIFICATE OF WATER RIGHT

**This is to certify, That** JOHN AND NORMA FLAMING

of Box 1, Fort Rock, State of Oregon 97735, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells 1 and 4

a tributary of Fort Rock Basin for the purpose of irrigation of 267.6 acres

under Permit No. G-9348 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 28, 1981 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.35 cubic feet per second, being 1.76 cfs from well 1 and 1.59 cfs from well 4

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 NW 1/4, Lot 3 (NW 1/4 SW 1/4), Section 19, T25S, R15E, WM; Well 1 - 1330 feet South and 1440 feet East; Well 4 - 3700 feet South and 1310 feet East, both from NW Corner, Section 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
