CERTIFICATE OF WATER RIGHT

This is to certify, *That* CROOK COUNTY CEMETERY DISTRICT

of Prineville, State of Oregon 97754, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of waste and seepage from Ochoco Irrigation District

a tributary of Crooked River for the purpose of supplemental irrigation of 30.1 acres

under Permit No. 24083 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.34 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, Section 32, T14S, R16E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year; and shall also be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.8 acres NE 1/4 NE 1/4
1.2 acres SW 1/4 NE 1/4
22.2 acres SE 1/4 NE 1/4
1.8 acres NE 1/4 SE 1/4
0.1 acre NW 1/4 SE 1/4

Section 31

Township 14 South, Range 16 East, WM

This certificate describes the water right confirmed by the prior certificate recorded at page 31033, Volume 23, State Record of Water Right Certificates, changed from primary irrigation to supplemental irrigation by the provisions of an order of the Water Resources Director entered on December 27, 1984.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
