CERTIFICATE OF WATER RIGHT

This is to certify, That RAYMOND JONES

proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Tycer Creek, Perdin Creek and three reservoirs constructed under Permit R-8161 a tributary of East Fork Illinois River for the purpose of operation of hydraulic ram, irrigation of 1.4 acres and supplemental irrigation of 4.0 acres under Permit No. 44977 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1979

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second, being 0.11 cf5 from fycer Creek for operation of

the ram, 0.03 cfs from Tycer Creek when available with any deficiency in the available supply from Tycer Creek to be made up by diversion of water from * or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of

diversion is located in the SW 1/4 NE 1/4, Section 19, T39S, R7W, WM; Tycer Creek - 210 feet South and 770 feet West; Perdin Creek - 30 feet South and 525 feet West; Reservoir No. 3 - 75 feet South and 390 feet West, all from NE Corner, SW 1/4 NE 1/4, Section 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* Perdin Creek and the three reservoirs provided that the total quantity from all sources shall not exceed 0.03 ofs for irrigation, and 0.08 ofs from Perdin Creek and the three reservoirs for supplemental irrigation
