CERTIFICATE OF WATER RIGHT

This Is to Certify, That WAYNE J. BLAYLOCK

of Riverside, State of Oregon 97917, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three unnamed streams and reservoirs No. 1, No. 2, and No. 3, constructed under Permit R-5403, a tributary of South Fork Malheur River for the purpose of irrigation of 7.8 acres and supplemental irrigation of 28.2 acres

under Permit No. 34061 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 5, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second being 0.07 cfs from diversion 1, 0.03 cfs from diversion 2 and 0.10 cfs from diversion 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, SE 1/4 SW 1/4, Section 20, T24S, R37E, WM; Diversion 1 - 1100 feet North and 3100 feet East, Diversion 2 - 700 feet North and 2080 feet East, Diversion 3 - 280 feet North and 1800 feet East, all from SW Corner, Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permit R-5403 and further limited to the use of stored water only on the lands described as supplemental.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
