## CERTIFICATE OF WATER RIGHT

This is to certify. That A.W. BORLAND, JR. AND F. FUCHS

of Route 2, Box 2510, Hermiston .State of Oregon 97838 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells.

a tributary of Columbia River irrigation of 4.1 acres

for the purpose of

under Permit No. G-1314 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0,05 cubic foot per second; being 0,025 cbc from each well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is SE 1/4 NE 1/4, Section 34, T5N, R28E, WM; Boriand - 360 feet South and 440 feet West; Fuchs - 260 feet South and 980 feet West; both from NE Corner, SE 1/4 NE 1/4, Section 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

FUCHS 2.0 acres SE 1/4 NE 1/4 Section 34 BORLAND 2.1 acres SE 1/4 NE 1/4 Section 34

Township 5 North, Range 28 East, WM Township 5 North, Range 28 East, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered November 25, 1980 and together with certificate of water right recorded at page 49953, Volume 44, State Record of Water Right Certificates supersedes certificate of water right recorded at page 31285, Volume 23, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
