CERTIFICATE OF WATER RIGHT

This is to certify, That JIM AND DAVE BLATCHFORD

of Route 1, Box 154, Baker, State of Oregon 97814, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well 2 and 3

a tributary of Powder River for the purpose of supplemental irrigation of 324.2 acres

under Permit No. G-10138 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1983 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.06 cubic feet per second; being 1.61 cfs from Well 2 and 2.45 cfs from Well 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 SW 1/4, NW 1/4 SE 1/4, Section 16, T8S, R39E, WM; Well 2 - 1210 feet South and 50 feet East from W 1/4 Corner, Section 16; Well 3 - 1320 feet North and 1370 feet West from SE Corner, Section 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
