CERTIFICATE OF WATER RIGHT

This Is to Certify, That SANDY FARMS

of 34500 SE Highway 211, Boring, State of Oregon 97009, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Sandy Farms Reservoir 1-A constructed under Permit R-6468

a tributary of Tickle Creek for the purpose of supplemental irrigation of 244.9 acres

under Permit No. 40582 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 9, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 47.2 acre-feet, stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, Section 21, T2S, R4E, WM; 2730 feet North and 500 feet West from SE Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~per-acre~~ ~~of one cubic foot per second~~ not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from reservoir constructed under Permit R-6468

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
