CERTIFICATE OF WATER RIGHT

This is to certify, That WALLACE INGEBRAND

of Route 1, Box 108, Amity, State of Oregon 97101, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Salt Creek and Wallace Ingebrand Reservoir constructed under Permit R-6584

a tributary of South Yamhill River for the purpose of irrigation of 13.35 acres and supplemental irrigation of 47.83 acres

under Permit No. 41554 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1976 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.76 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, SW 1/4 NE 1/4, NE 1/4 NW 1/4 all within Comegys DLC 49, Section 15, T6S, R5W, WM; Reservoir - 800 feet South and 1870 feet West from the NE Corner, Section 15; Pump Site No. 1 - 2550 feet South and 675 feet West; Pump Site No. 2 - 2300 feet South and 1140 feet West, both from the NE Corner, Comegys DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-6584, provided further that the right allowed herein shall be limited to the use of stored water only on the lands described as supplemental,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

PRIMARY IRRIGATION

6.55 acres NE 1/4 NW 1/4 as projected within Comegys DLC 49
4.50 acres SE 1/4 NW 1/4 as projected within Comegys DLC 49
2.30 acres Lot 2 (SE 1/4 NW 1/4)

SUPPLEMENTAL IRRIGATION

2.40 acres NW 1/4 NE 1/4 as projected within Comegys DLC 49
3.20 acres SW 1/4 NE 1/4 as projected within Comegys DLC 49
2.40 acres SE 1/4 NW 1/4 as projected within Comegys DLC 49
33.03 acres (Lot 1) SW 1/4 NE 1/4
6.80 acres (Lot 2) SE 1/4 NW 1/4

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
