CERTIFICATE OF WATER RIGHT

of Route 1, Box 10, Ecno , State of Oregon 97826 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Umatilla River for the purpose of irrigation of 11.5 acres and supplemental irrigation of 104.5 acres

under Permit No. G-6574 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 17, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.15 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the $\,$ SW 1/4, SW 1/4, Section 12, T3N, R28E, WM; 1280 feet North and 1250 feet East from the SW Corner, Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

In processing the application towards issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water to not exceed 1/80th of one cubic foot per second per acre and 2 1/2 acre feet per acre. In the issuance of this certificate, the duty of water has been raised to 1/80th cubic foot per second per acre and 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of the proper maximum limits.
