CERTIFICATE OF WATER RIGHT

This is to certify, That GENE UNDERHILL

of Route 1, Box 234, Dufur, State of Oregon 97021, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Ramsey Creek for the purpose of supplemental irrigation of 34.6 acres

under Permit No. G-8959 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 12, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 SE 1/4, Section 31, T1S, R13E, W4M; 400 feet North and 1980 feet West from the SE Corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the amount of water diverted from the channel of Fifteenmile Creek shall not exceed the amount by which the flow of Fifteenmile Creek at the point of diversion is increased above the natural flow by the operation of the well, and approved measuring devices shall be maintained on the well's discharge into and* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

*rediversions from any stream used for transporting ground water and be reduced by any transmission losses incurred, and shall be further limited to appropriation of water that does not impair or substantially interfere with existing surface water rights.
