of 34500 SE Highway 211, Boring , State of Oregon 97009 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and reservoir constructed under Permit R-1441

a tributary of Tickle Creek for the purpose of irrigation of 219.9 acres and supplemental irrigation of 33.2 acres

under Permit No. 21838 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

October 8, 1952
that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.69 cubic foot per second, if available at the original point of diversion; NE 1/4 SE 1/4, Section 21, TZS, R4E, Wm; 198 feet South and 383 feet West from E 1/4 Corner, Section 21.

or its equivalent in case of rotation, measured at the point of diversion from the stream
The point of diversion is located in the SE 1/4 NE 1/4, Section 21, T2S, R4E, WM;
2730 feet North and 500 feet West from SE Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre. or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1441

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
