under Permit No. 4803 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 25, 1920

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.004 cubic foot per second, if available at the original point of diversion, SW 1/4 SE 1/4, Section 14, T29S, R5W, WM; 13.09 chains North and 0.46 chain West from SW Corner Henry Jones DLC 48.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SW 1/4, Section 14, T29S, R5W, WM; 25 feet North and 1550 feet East from SW Corner, Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered July 31, 1979 and together with Certificate of Water Right recorded at page 48650, Volume 42, and certificates of water right recorded at pages 52958, 52960, 52961, 52962, 52963, 52964, 52965, 52966, 52967, 52968, 52969, 52970, 52971, Volume 48, State Record of Water Right Certificates supersedes certificate Adnata.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
