This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered May 31, 1979 and together with Certificate of Water Right recorded at page 48650, Volume 42, and certificates of water right recorded at pages 52958, 52959, 52960, 52961, 52962, 52963, 52964, 52965, 52965, 52969, 52971, Volume 48, State Record of Water Right Certificates supersedes certificate 44047.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
