## CERTIFICATE OF WATER RIGHT

under Permit No. 8731 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 15, 1928

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second, if available at the original point of diversion; NW 1/4 NE 1/4, Section 24, T13S, R26E, WM; Cummings Ditch - 1,200 feet South and 2,650 feet East from NW Corner, Section 24.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE\ 1/4\ NW\ 1/4$ , SW  $1/4\ NW\ 1/4$ , Section 18, T13S, R27E, WM; Diversion 2 - 1,090 feet South and 1,970 feet East; Diverson 1 - 1,710 feet South and 500 feet East both from NW Corner, Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
