## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Murphy , State of Oregon 97533 , has a right to the use of the waters of Applegate River

a tributary of Rogue River stock and irrigation of 43.1 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at page523; that the priority of the right thereby confirmed dates from 1906

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.86 cubic foot per second.

The point of diversion is located in the NE 1/4 NW 1/4, Section 25, T38S, R4W, WM.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

4.7 acres SW 1/4 NW 1/4 Section 17 described as follows:

Beginning at the SE corner of NE 1/4 SW 1/4, Section 17; thence West 11 chains; thence North 46 degrees West 22.11 chains to the true point of Beginning; thence North 46 degrees 45 minutes East 9.90 chains; thence North 38 degrees 15 minutes West 4.02 chains; thence North 45 degrees East 19.02 chains; thence West 29.83 chains to the West line of said Section 17; thence South 13.45 chains to the center of the county road; thence Southwesterly along the center of said county road to the point of beginning.

15.8 acres NW 1/4 SW 1/4 Section 17 described as follows:

Commencing at an iron pipe set for a corner on the quarter line being 20 chains South and 7.65 chains East from the quarter section corner between Sections 17 and 18, T.38 S., R. 4 W., W.M., in Jackson County, Oregon, and running thence East 12.35 chains to the SE corner of the NW 1/4 SW 1/4; thence North 8.50 chains to a pipe in center of county road; thence North 46 degrees West in center of county road 17 chains, more or less, to an iron pipe for a corner; thence South 20.83 chains to the place of beginning, containing 17.87 acres, more or less.

## 3.8 acres NE 1/4 SW 1/4 Section 17 described as follows:

Commencing at the SW corner of NE 1/4 SW 1/4 of Section 17, T. 38 S., R. 4 W., W.M., in Jackson County, Oregon, and running thence East 9 chains; thence North 46 degrees West along the center of the county road 13 chains, more or less, to an iron pipe for a corner; thence South 8.50 chains to the place of beginning, containing 3.62 acres, more or less.

10.0 acres Lot 3 (SE 1/4 SW 1/4) 8.8 acres SW 1/4 SW 1/4 Section 17 Township 38 South, Range 4 West, WM

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 32890, Volume 24, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on July 20, 1983, approving Transfer Application 5265.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
