CERTIFICATE OF WATER RIGHT

This is to certify, That M. W. IRWIN

of 39006 Richardson Gap Rd., Scio, State of Oregon 97374, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Thomas Creek

a tributary of South Santiam River for the purpose of irrigation of 23.2 acres

under Permit No. 20571 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 22, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second, if available at the original point of diversion; SW 1/4 NE 1/4 and SE 1/4 NE 1/4 as projected within J. Thomas DLC 47, Section 9, T10S, R1W, WM

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4 as projected within J. Thomas DLC 47, Section 9, T10S, R1W, WM; 1350 feet North and 1390 feet East from SW Corner J. Thomas DLC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres SW 1/4 NE 1/4 as projected within J. Thomas DLC 47
20.0 acres NW 1/4 SE 1/4 as projected within J. Thomas DLC 47
Section 9
Township 10 South, Range 1 West, WM

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered June 17, 1981 and supersedes certificate of water right recorded at page 23888, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
