CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* SMITH BROTHERS

of Prairie City, State of Oregon 97869, has
a right to the use of the waters of Pine Creek

a tributary of John Day River for the purpose of
irrigation of 165.8 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Grant County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 15, at page 461; that the priority of the
right thereby confirmed dates from 1908

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one-fortieth
cubic foot per second per acre irrigated to June 1, and one-eightieth cubic
foot per second per acre thereafter; further limited to one acre-foot per
calendar month to June 1 and four acre-feet per acre during season April 1 to
September 30, measured at point of diversion.
