or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN 1/4 NN 1/4, Section 12, T145, R32 $^{-}$, NM; Spring No. 1 - 670 feet South and 660 feet West, Spring No. 2 - 370 feet South and 280 feet West, Spring Area No. 3 - 420 feet South and 630 feet West, Unnamed Stream No. 5 - 270 feet South and 340 feet West, all from the NC Corner of NN 1/4 NN 1/4, Section 12. The amount of water used for irregation, together with the amount secured under any other right

existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre.
