This is to certify, That KENNETH LA FON

of 40355 Little Fall Creek Rd., Fall Creek , State of Oregon 97438 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette Basin project reservoirs constructed under Permit R-1625 above the point of diversion a tributary of Willamette River for the purpose of supplemental irrigation of 27.1 acres

accordance with the laws of Oregon, that the priority of the right hereby confirmed dates from March 21, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 58,27 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE 1/4 SW 1/4), Lot 4 (SE 1/4 NW 1/4), Section 15, 720S, R3W, WM: 1 - 1980 feet North and 2270 feet West; 2 - 2440 feet North and 2170 feet West; 3 - 730 feet North and 2350 feet West; all from SE Corner, Coverdill OLC 52

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from Willamette Basin project Reservoirs constructed under Permit No. R-1625 and is subject to the terms and conditions of contract No. 7-07-10-W0042 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department, conform to such reasonable totation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
