CERTIFICATE OF WATER RIGHT

This is to certify, That

KENNETH LA FON

of 40355 Little Fall Creek Rd., Fall Creek State of Oregon 97438 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coast Fork Millamette River and Millamette Basin project reservoirs above the point of diversion described herein, constructed under Permit R-1625 a tributary of Willamette River for the purpose of irrigation of 40.6 acres

under Permit No. 42525 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 21, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.51 cubic Foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 $_{
m NN}$ 1/4 as projected within Coverdill DLC 52, Section 15, T2OS, R3W, WM; 310 feet South and 2170 feet West from the NW Corner Vandervert DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acr irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from Reservoirs constructed under Permit R-1625 and is subject to the terms and conditions of Contracts 7-07-10-W0043, 7-07-10-W0044 and 7-U7-10-W0045 and storage from replacements between the Bureau of Reclamation and the applicant, copies of which are on file in the records of the Water Resources Department, and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.0 acres Lot 8 (SE 1/4 SW 1/4)
6.8 acres SE 1/4 SW 1/4 as projected within Coverdill DLC 52
7.0 acres Lot 10 (NW 1/4 SE 1/4)
14.8 acres Lot 9 (SW 1/4 SE 1/4)
Section 10
Township 20 South, Range 3 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
