a tributary of Pacific Ocean irrigation of 302.6 acres

for the purpose of

under Permit No. 38225 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 4, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.57 cubic feet per second, being 1.33 cfs for Crisp and 6.24 cfs for Sullivan

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4, Section 1, T3N, R22E, WM; 3690 feet North and 2610 feet West from SE Corner, Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, $\,$ or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to a total diversion of 7.8 cfs for the Sullivan lands under this right together with the rights described by Certificates 51768, 51769, 52192 and 52606, these quantities being the full capacity of Sullivan's system,

conform to such reasonable rotation system as may be ordered by the proper state officer.
