CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROSS AND BERNIECE SIMPSON

of Route 2, Vale, , State of Oregon 97910 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed stream and Dickson Reservoir constructed under Permit R-931

a tributary of Willow Creek for the purpose of irrigation of 1.0 acre and supplemental irrigation of 81.6 acres

under Permit No. 18200 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1948 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.06 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SW 1/4, Section 12, T15S, R38E, WM; 1880 feet South and 410 feet West from Center, Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated prior to May 1, and one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the remainder of the irrigation season from direct flow, provided further that the total quantity diverted from the direct flow and storage shall not exceed 3 acre-feet per acre during any irrigation season,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

In processing the application towards issuance of a permit, it appears that a clerical error was inadvertently made in limiting the duty of water to not exceed 3.5 acre-feet per acre irrigated. In the issuance of this certificate, the duty of water has been reduced to one-fortieth of one cubic foot per second per acre irrigated prior to May 1 and one-eightieth cfs per acre irrigated during the remainder of the irrigation season and 3 acre-feet per acre for each acre irrigated during the irrigation season of each year in keeping with the customary policy and determination of this office of the proper maximum limits.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
