CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROBERT AND BARBARA WOODCOCK

of Route 1, Box 279-B, Sheridan, State of Oregon 97378, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River and Mill Creek

a tributary of Yamhill River for the purpose of irrigation of 90.4 acres

under Permit No. 44147 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 11, 1979

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.13 cubic feet per second, being 0.56 cfs from South Yamhill River and 0.57 cfs from Mill Creek, with any deficiencies in the available supply of water from Mill Creek to be made up by diversion of water from South Yamhill River, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE 1/4 NW 1/4, SE 1/4 NE 1/4, Section 5, T6S, R6W, WM; S. Yamhill River - 850 feet South and 3660 feet West, Mill Creek - 1990 feet South and 490 feet West both from the NE Corner, Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
