CERTIFICATE OF WATER RIGHT

This is to certify, That JOHN DAVID PICKREL

of 6303 Fish Hatchery Road, Grants Pass, State of Oregon 97526, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Slate Creek

a tributary of Applegate River for the purpose of irrigation of 3.5 acres

under Permit No. 16596 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 19, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second, if available at the original point of diversion; NE 1/4 SE 1/4, Section 1, T37S, R7W,; 300 feet South and 1200 feet West from the E 1/4 Corner, Section 1.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, Section 1, T37S, R7W, WM, 170 feet South, and 650 feet West from the E 1/4 Corner, Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre.

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.5 acres NE 1/4 SE 1/4
Section 1
Township 37 South, Range 7 West, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 27, 1978 and together with certificate of water right recorded at page 46676, Volume 39, State Record of Water Right Certificates, supersedes Certificate 15674.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
