CERTIFICATE OF WATER RIGHT

This Is to Certify, That IRWIN MANN, JR.

of Route 2, Stanfield, State of Oregon 97383, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Umatilla River

a tributary of Columbia River for the purpose of irrigation of 20.7 acres

under Permit No. 30078 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 1, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE 1/4 NE 1/4, NW 1/4 NE 1/4, Section 34; NE 1/4 NE 1/4, NE 1/4 NW 1/4, NW 1/4 NW 1/4, Section 35; NE 1/4 NW 1/4, Section 36, T4N, R28E, WM; Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Diversion points located: 2040 feet North and 2240 feet West; 2490 feet North and 1050 feet West; 1920 feet North and 630 feet East; 2580 feet North and 1680 feet East; all from the West quarter Corner, Section 35; 2610 feet North and 1050 feet West; 1650 feet North and 2380 feet East; both from the West quarter Corner, Section 36.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 34389, Volume 26, State Record of Water Right Certificates, NDI modified by the provisions of an order of the Water Resources Director entered on March 25, 1985, approving transfer application No. 5586.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of QRS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
