CERTIFICATE OF WATER RIGHT

This is to certify, That ELMER L. COOK

of Route 2, Box 144, Albany, State of Oregon 97321, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Santiam River for the purpose of irrigation of 61.3 acres

under Permit No. G-7238 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 22, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.76 cubic foot per second, being 0.34 cfs from Well 1, 0.31 cfs from Well 2, and 0.11 cfs from Well 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Wells 1 and 2 - NW 1/4 NE 1/4, Section 33, Well 3 - SW 1/4 NE 1/4 all as projected within Harrison DLC 56, Section 33, T9S, R3W, WM; Well 1 - 1850 feet North and 1400 feet West, Well 2 - 1970 feet North and 2000 feet West, Well 3 - 880 feet North and 1270 feet West, all from SE Corner, Harrison DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
