CERTIFICATE OF WATER RIGHT

This is to certify, *That* CASPER S. OTT

of 3568 Blanchard Avenue, St. Paul, State of Oregon 97137, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Mission Creek for the purpose of primary irrigation of 16.0 acres from Well 1 and supplemental irrigation of 83.3 acres from Well 2 under Permit No. G-7096 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 19, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.04 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NW 1/4 as projected within St. Pauls Catholic Mission DLC 75, Section 19, T4S, R2W, WM; Well 1 - 880 feet South and 170 feet West; Well 2 - 480 feet South and 1240 feet West; both from the SE Corner Accolti DLC 73.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
