CERTIFICATE OF WATER RIGHT

This Is to Certify, That DAVE CHENEY

of Cecil Star Route, Ione, State of Oregon 97843, has a right to the use of the waters of Willow Creek

a tributary of Columbia River for the purpose of irrigation of 75.52 acres and domestic (stock) use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 73; that the priority of the right thereby confirmed dates from 1875 for domestic use and from 1892 for irrigation

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.27 cubic feet per second as of date 1892, if available at the original points of diversion; NE 1/4 NE 1/4, Section 20, (Ewing Ditch); NE 1/4 SE 1/4, Section 29, (Highline Ditch); 1160 feet South and 1000 feet West from NE Corner, Section 20; 3800 feet South and 40 feet West from NE Corner, Section 29, T2N, R23E, WM.

The point of diversion is located in the NE 1/4 NE 1/4, Section 20, (Ewing Ditch); NE 1/4 SE 1/4, Section 29, (Highline Ditch); NE 1/4 NE 1/4, Section 7, (Additional Point of Diversion); 1160 feet South and 1000 feet West from NE Corner, Section 20; 3800 feet South and 40 feet West from NE Corner,\*

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

\*Section 29; 930 feet South and 470 feet West from NE Corner, Section 7, T2N, R23E, WM.

This certificate is issued to confirm the additional point of diversion approved by an order of the Water Resources Director entered May 22, 1979, and supersedes certificate of water right recorded at page 139, Volume 1, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
