CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAUN BROTHERS

of Route 1, Box 52, Lostine , State of Oregon 97857 , has
a right to the use of the waters of South Fork Wallowa (Lostine) River

a tributary of Wallowa River for the purpose of
irrigation of 5.26 acres and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Wallowa County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 5, at page 157 ; that the priority of the
right thereby confirmed dates from 1896

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1.5 acre-feet per
acre during any period of 30 days prior to July 31 of each year, and
thereafter not to exceed 1 acre-foot per acre during the entire remainder of
the irrigation season; if available at the original point of diversion; SE 1/4
SW 1/4, Section 15, T1S, R43E, WM; 950 feet North and 2365 feet East from SW*
The point of diversion is located in the NW 1/4 NE 1/4, Section 22, T1S, R43E, WM; 830
feet South and 2700 feet East from the NW Corner, Section 22 (Lostine Ditch)

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

*Corner, Section 15 (Wood-Boatman Ditch).

5.26 acres SW 1/4 SE 1/4
Section 3

Township 1 South, Range 43 East, WM

Land upon which water is used more explicitly described as Blocks 16 and 17,
N 1/2 of Block 19; N 1/2 of Block 12, Lots 1, 2, 3, 4, 5, 9, 10, 11, 12, 13,
14, 15 and 16 of Block 9, in the Town of Evans, Wallowa County, Oregon.

This certificate is issued to confirm a change in point of diversion approved
by an order of the Water Resources Director entered December 13, 1977, and
supersedes certificate of water right recorded at page 2989, Volume 4, State
Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of
the water right in regard to the provisions of ORS 540.610 pertaining to
forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
