and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at page 171; that the priority of the right thereby confirmed dates from 1896

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31 of each year, and thereafter not to exceed 1 acre-foot per acre during the entire remainder of the irrigation season; if available at the original point of diversion; SE 1/4 SW 1/4, Section 15, TIS, R43E, WM; 950 feet North and 2365 feet East from SW* The point of diversion is located in the NW 1/4 NE 1/4, Section 22, TIS, R43E, WM; 830 feet South and 2700 feet East from the NW Corner, Section 22 (Lostine Ditch)

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

*Corner, Section 15 (Wood-Boatman Ditch).

2.85 acres NW 1/4 SE 1/4 4.05 acres SW 1/4 SE 1/4 Section 3

Township 1 South, Range 43 East, WM

Land upon which water is used more particularly described as Blocks 1, 2, 3 and 15: Lots 1, 2, 3, 14, 15, 16 in Block 6: S 1/2 of Block 5: Lots 3, 4, 5, 6, 7 and 8 in Block 5: Lots 1, 2, 15 and 16 of Block 8: Lots 9, 10, 11, 12, 13, 15, 16 in Block 12 in the Town of Evans in Wallowa County, Oregon.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered December 13, 1977, and together with certificates of water right recorded at page 45010, Volume 37, and page 53405, Volume 48, State Record of Water Right Certificates, supersedes Certificate 37398.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
