CERTIFICATE OF WATER RIGHT

This is to certify, That VERL E. NOFZIGER

of P.O. Box 252, Christmas Valley, State of Oregon 97641, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of wells 1 and 2

a tributary of Fort Rock Basin for the purpose of irrigation of 264.0 acres

under Permit No. G-9126 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 13, 1981

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.30 cubic feet per second, being 1.61 cfs from well 1 and 1.69 cfs from well 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NW 1/4, SW 1/4 SW 1/4, Section 23, T26S, R16E, WM; Well 1 - 3940 feet North and 1320 feet West, Well 2 - 1320 feet North and 1320 feet West, both from S 1/4 Corner, Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- WELL 1
- 29.5 acres NE 1/4 NW 1/4
- 32.0 acres NW 1/4 NW 1/4
- 33.3 acres SW 1/4 NW 1/4
- 34.2 acres SE 1/4 NW 1/4
- WELL 2
- 34.0 acres NE 1/4 SW 1/4
- 33.2 acres NW 1/4 SW 1/4
- 33.7 acres SW 1/4 SW 1/4
- 34.1 acres SE 1/4 SW 1/4
- Section 23
- Township 26 South, Range 16 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
