CERTIFICATE OF WATER RIGHT

This Is to Certify, That PINE LAKES DITCH and RESERVOIRS COMPANY
c/o Floyd Taylor, Secretary-Treasurer

of Half way , State of Oregon 97834 , has made
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
Pine Creek and East Lake Reservoir constructed under Permit R-2309

a tributary of Snake River for the purpose of
irrigation of 400.5 acres and supplemental irrigation of 2213.9 acres

under Permit No. 26491 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
October 7, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
9.52 cubic feet per second from Pine Creek and 132.5 acre-feet from East Lake
Reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the Reservoir--SE 1/4 NW 1/4, Section 10, T6S,
R45E, WM; Creek--NE 1/4 SE 1/4, Section 15; NE 1/4 NE 1/4, Section 22; SE 1/4
NW 1/4, SW 1/4 SE 1/4, Section 23; NW 1/4 SW 1/4, Section 25; NE 1/4 NE 1/4,
Section 26, T7S, R45E, WM; 1,930 feet North and 1,020 feet West (Moore), 1,620
feet North and 1,010 feet West (Curry), 170 feet South and 200 feet West*

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated from direct flow and shall
be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre
for each acre irrigated during the irrigation season of each year from direct
flow and storage from reservoir constructed under Permit R-2309,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right
is appurtenant, is as follows:

*(Posey Valley) all from SE Corner, Section 15; 3,050 feet North and 3,780
feet West (Steel), 980 feet North and 2340 feet West (Foothills), 350 feet
North and 1,830 feet West (Gaylord), 1,050 feet South and 1,100 feet West
(Mills), 2,900 feet South and 400 feet East (Tarters Slough); all from NE
Corner, Section 26, T7S, R45E, WM.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow established by the Water Resources Commission with an effective date prior to this right.
