CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DESCHUTES FARMERS CO-OP, A CORPORATION

c/o George F. Rakestraw
 of 632 South 6th Street, Redmond, State of Oregon 97756, has made
 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
 Deschutes River

a tributary of Columbia River for the purpose of
 irrigation of 98.0 acres

under Permit No. 19418 and that said right to the use of said waters has been perfected in
 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
 May 15, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
 aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
 1.774 cubic feet per second; subject to the terms and conditions of a waiver
 recorded on pages 440 and 441, Volume 3, Miscellaneous Records of the State
 Engineer and by reference made a part hereof,

or its equivalent in case of rotation, measured at the point of diversion from the stream.
 The point of diversion is located in the NW 1/4 NW 1/4, Section 15, T14S, R12E, WM.

The amount of water used for irrigation, together with the amount secured under any other
 right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second
 per acre, or its equivalent for each acre irrigated and shall be
 further limited to a diversion of not to exceed 4 acre-feet per acre for each
 acre irrigated during the irrigation season of each year

and shall
 conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right
 is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 24637, Volume 17, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on August 13, 1985, approving Transfer Application 5647.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
