that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.774 cubic feet per second; subject to the terms and conditions of a waiver recorded on pages 440 and 441, Volume 3, Miscellaneous Records of the State Engineer and by reference made a part hereof,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW 1/4 NW 1/4 Section 15, T148, R12E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre,
